

## **INFORMATION FOR FILING A PRO SÉ PETITION-RAINS COUNTY DISTRICT CLERK**

**THE DISTRICT CLERK'S OFFICE DOES NOT SUPPLY FORMS NECESSARY FOR FILING.  
WE ARE NOT ATTORNEYS AND ARE LEGALLY PROHIBITED FROM GIVING ANY LEGAL ADVICE.**

If you intend to represent yourself "ProSé", (without the assistance of an attorney), you must have the knowledge to prepare and file the necessary pleadings and present your cause to the Court.

We can only recommend that you consult with an attorney concerning questions regarding the law OR refer to the list of legal aid resources available at the end of this document.

### **PROCEDURES FOR FILING YOUR OWN CIVIL ACTION**

1. Bring your **Original Petition and 2 copies** to the District Clerk's Office to be filed. If you are filing a divorce or other parent-child relationship pleading, you must attached a copy of the Rains County Standing Order. You will also need to complete the vital statistics form and a Record of Support form. The Standing Order and forms are available, and may be picked up, in the District Clerk's Office or accessed through the District Clerk's website at [www.co.rains.tx.us](http://www.co.rains.tx.us)
2. The filing fees may be found in the "**Current Filing Fees**" link (*be sure to include any citation and service fees necessary*)- Fees are due at the time of filing. If you are unsure about fees, please contact the District Clerk's Office.
3. Your petition will be filed and assigned a cause number and court. Please have this information available when contacting our office concerning your case. The District Clerk's phone number is 903-473-5000 ext. 101 or ext. 102. *Failure to have your cause number will result in a \$5.00 search fee pursuant to Government Code 51.318(b)(3).*
4. If your Petition is for a divorce, it must be on file at least **60 days** before a final hearing can be held. After the 60 days have expired and your paperwork is in order, you may appear before the Court to have the final decree entered.
5. If you or your spouse will be receiving child support, you must return to the District Clerk's Office and give required information to set up a child support account that will be collected and disbursed through the State Disbursement Unit in San Antonio.
6. To obtain available hearing dates for any case call the District Clerk's Office at 903-473-5000 ext 101 or ext 102. All hearing requests **must** be received in writing.
7. Report to the district courtroom and wait for the Court to call your case. **The Judge cannot assist you. You must know how to present the required elements of your case to the Judge for consideration.**
8. When you come to the courthouse annex for your final hearing, bring your completed **Order and 2 copies**, which you will submit to the Judge following your hearing for approval and signing.
9. Pursuant to the Local Court Rules dated **June 12, 1998**,
  - In **ALL** suits affecting parent-child relationship filed on or after **July 1, 1998** in Rains County, Texas, involving children under the age of 18, **all parties will be required** to enroll and present certification of completion of the "Kids First" seminar *before* any final hearing date is set. Each party is responsible for payment of the appropriate fee. See [www.kidsfirsttoday.com](http://www.kidsfirsttoday.com) or call (361) 275-8057.
  - The seminar shall be attended within 60 days of service of the Original Petition upon the original respondent.
  - A party's failure to attend the seminar pursuant to this rule will result in contempt, sanctions, postponement of the final hearing and entry of a final decree.
  - For good cause shown, the judge may waive the attendance requirement in individual cases.
  - Information on this required seminar is available in the District Clerk's Office.

YOU MAY ALSO RECEIVE CERTIFIED COPIES OF YOUR FINAL ORDER AT THIS TIME. THE COST IS \$1 PER PAGE.
