## EXTENDED ICE STORM EVENT PREPARATION ADVISORY

### 90+ Hour Event with Potential Multi-Day Power Outages

Rains County Judge's Office

*Issued January 23, 2026 at 3:20pm*

---

### IMMEDIATE ACTION REQUIRED: PREPARE NOW

An extended icing event is forecast with potential power outages lasting multiple days. **Residents must begin preparation immediately.** This advisory provides essential information to protect your family, home, and property during this extended weather event.

---

### CRITICAL TIMELINE

- **Before Storm:** Complete all charging and fuel preparations
- **During Storm:** Remain indoors, avoid travel, monitor emergency broadcasts
- **After Storm:** Assess damage, report hazards, follow road closure advisories

## BATTERY AND ELECTRONIC DEVICE CHARGING

Charge all devices **immediately** and maintain charging throughout the event:

### Personal Electronics

- Cell phones and mobile devices (consider charging in vehicle)
- Tablets and laptop computers
- Portable power banks and battery packs
- Rechargeable flashlights and lanterns
- Hearing aids and medical alert devices
- CPAP machines and respiratory equipment (have backup power plan)

### Home Preparation

- Battery-powered NOAA Weather Radio (essential for storm updates and emergency alerts)
- Portable battery-powered or hand-crank radio for information reception
- Flashlights with fresh, extra batteries (multiple units recommended)
- LED lanterns with backup batteries
- Digital thermometers for food safety monitoring

### Generator and Backup Power

- Fill generators with fuel **before the storm** (refueling after outage begins may be impossible)
- Store fuel cans safely and away from living spaces
- **CRITICAL SAFETY:** Never operate generators indoors, in garages, basements, or enclosed spaces—they produce deadly carbon monoxide. Generators must be outside, at least 20 feet from windows, doors, and vents
- Test generator operation before the storm

- Ensure carbon monoxide detectors are functional and outside vents are clear of debris

---

## FUEL REQUIREMENTS

### Vehicle Gas Tanks

- Fill all vehicle fuel tanks to capacity **before the storm**
- Fuel stations may close due to power outages or be unreachable after the event
- Do NOT rely on finding fuel during or immediately after the event
- Consider extra fuel for generators (in approved containers)
- Keep fuel stored safely outside in clearly labeled containers

### Heating Fuel

- Ensure adequate fuel for fireplaces, wood stoves, or kerosene heaters
- If using kerosene heaters: refuel **outside only**, maintain 3-foot clearance from flammable objects, ensure proper ventilation to prevent carbon monoxide accumulation
- **CRITICAL:** Never use charcoal grills, camp stoves, or oven burners for heating—they produce deadly carbon monoxide indoors
- Cut and stack firewood before the storm

---

## FOOD AND WATER SUPPLIES

### Drinking Water (Essential)

- **Minimum 1 gallon per person per day** for 4+ days (recommend 2 gallons per person)
- Include water for pets
- Stock bottled water and additional tap water containers

- Fill bathtubs with water for non-potable uses (toilet flushing, cleaning)
- Freeze water containers to help preserve refrigerated food and provide extra drinking water as they melt

## **Food (No Cooking Required)**

Stock non-perishable, ready-to-eat foods requiring no cooking or refrigeration:

### **Protein and Nuts:**

- Peanut butter (shelf-stable)
- Nuts and seeds
- Canned or packaged tuna and chicken
- Beef jerky and meat snacks
- Protein bars and granola bars
- Canned beans and legumes

### **Fruits and Vegetables:**

- Dried fruit (raisins, dried cranberries, dried apples)
- Canned fruits (apples, peaches, pears, pineapple)
- Canned vegetables (corn, green beans, carrots)
- Applesauce pouches

### **Grains and Carbohydrates:**

- Granola and cereal (eaten dry or with shelf-stable milk)
- Crackers and whole grain bread
- Oatmeal and instant breakfast items
- Ready-to-eat meals and MREs (Meals Ready to Eat)

### **Beverages and Supplements:**

- Instant coffee and hot chocolate (can be heated with proper ventilation)
- Herbal tea bags

- Shelf-stable milk and non-dairy milk alternatives
- Electrolyte drink mixes or sports drinks

## **Baby and Pet Supplies:**

- Extra infant formula (non-perishable)
- Extra diapers
- Pet food for entire outage period
- Pet water (minimum 1 gallon per pet for several days)

**Important:** Include a manual can opener and utensils for preparing canned foods.

---

## **REFRIGERATOR AND FREEZER MANAGEMENT**

### **Before the Storm**

- Set refrigerator to 40°F or below
- Set freezer to 0°F or below
- Freeze water containers and ice (for cooling if power fails)
- Place penny on top of frozen cup in freezer—if penny is displaced after power outage, freezer contents warmed and thawed; discard uncertain items

### **During Power Outage**

- **Keep refrigerator and freezer doors CLOSED** (critical for food safety)
- Unopened refrigerator maintains safe temperature for approximately 4 hours
- Full freezer maintains safe temperature for up to 48 hours
- Do NOT reopen doors to check contents

## After Power Restoration

- Discard perishable foods that reached 40°F or above for 4+ hours
- **When in doubt, throw it out** — appearance and smell are not reliable food safety indicators
- Follow FDA guidelines: if uncertain about temperature history, discard item

---

## HEATING AND COLD-WEATHER PREPARATION

### Alternative Heat Sources

- Fireplace with adequate wood supply or gas fireplace with fuel
- Wood-burning stove with fuel
- Propane or natural gas stove (with proper ventilation)
- Space heaters with automatic shutoff (ensure 3-foot clearance from flammable objects)

### Heating Safety Requirements

- Never use charcoal grills, camp stoves, or ovens for heat
- Never run generators in enclosed spaces
- Ensure carbon monoxide detector is functional
- Check smoke alarms monthly; replace batteries if needed

### Cold-Weather Gear and Comfort

- Winter coats, hats, scarves, insulated gloves, thermal socks, boots
- Multiple heavy blankets per family member
- Electric blankets (if backup power available—uses minimal power)
- Hand warmers and hot water bottles

- Sleeping bags (for warmth huddle in one room with minimal heating)

## Pipe Freeze Prevention

- Insulate and wrap exterior water pipes
- Disconnect and drain outdoor hoses
- Allow water to trickle from faucets (especially interior sinks on exterior walls)
- Open cabinet doors under sinks to allow warm air circulation
- Seal any cracks around pipes entering the home

---

## MEDICATIONS AND MEDICAL NEEDS

### Essential Medication Supplies

- 7+ days of all prescription medications (not just 2-3 days)
- Over-the-counter medications: pain relievers, antihistamines, anti-diarrheal, antacid
- First-aid kit with bandages, antiseptic, pain relief, tweezers
- Thermometer (for fever monitoring)
- Medical alert identification (if applicable)

### Medical Device Planning

- CPAP/BiPAP users: arrange backup battery power or alternative sleep arrangements
- Oxygen equipment: ensure backup supply and battery backup for compressors
- Diabetic supplies: store at proper temperature (insulin requires cool environment)
- Dialysis and other ongoing treatments: contact your provider NOW for backup plan

- Mobility aids, walkers, canes: ensure accessible if power affects charging
- 

## PERSONAL HYGIENE AND SANITATION

### Hygiene Supplies

- Dry shampoo (for hygiene without water)
- Water wipes and washcloths
- Hand sanitizer and antibacterial wipes
- Toilet paper, tissues, paper towels (ensure adequate supply)
- Feminine hygiene products
- Diapers and incontinence products
- Soap and other toiletries

### Sanitation if Water Service Affected

- Fill bathtub with water for flushing toilets
  - Provide bucket near toilet for water scooping
  - Disinfectant wipes and cleaners
  - Garbage bags for waste management
  - Consider portable chemical toilet or camping toilet as backup
- 

## DOCUMENT AND FINANCIAL PREPAREDNESS

### Important Documents and Information

- Keep in waterproof/fireproof document bag or container:
  - Birth certificates and Social Security cards

- Insurance policies (homeowners, auto, health, life)
- Property deeds and mortgage documents
- Bank account information and passwords (written securely)
- Medical records and medication lists
- Identification documents
- Utility account numbers
- Property photos for insurance claims

## Financial Considerations

- Withdraw cash **before the storm** (ATMs and card readers may not function during outages)
- Store cash in secure location
- Have small bills for transactions (stores may lack change-making capability)
- Note utility company emergency numbers

---

## PET AND LIVESTOCK PREPARATION

### Pet Emergency Supplies

- Extra pet food for entire outage period (minimum 7 days)
- Extra pet water (minimum 1 gallon per pet for several days)
- Pet medications and first-aid supplies
- Leashes, carriers, and ID tags
- Litter and litter box (for indoor cats)
- Warm bedding and shelter
- Waste bags and disposal supplies

## Livestock Considerations

- Ensure adequate feed and hay supply stored and protected
  - Have water supply plan (heated water stations, de-icer)
  - Shelter from ice and wind (clean, dry areas with windbreak)
  - Accessible veterinary emergency contacts
  - Current photos and identification for livestock (in case displaced)
- 

## VEHICLE EMERGENCY KIT

Keep in each vehicle:

- Mobile phone charger (car charger)
- Blankets and emergency blankets
- Winter clothing (extra coat, gloves, hat)
- Hand warmers
- Flashlight with extra batteries
- First-aid kit
- Non-perishable food and bottled water
- Windshield de-icer and ice scraper
- Sand, salt, or cat litter (for traction if stuck)
- Jumper cables and battery booster pack
- Tire chains (if applicable to your area)
- Shovel
- Tool kit
- Tow rope
- Jack and spare tire (ensure tire has air)
- Tire inflator

**Critical:** Do NOT travel during ice storm unless absolutely necessary.  
Emergency vehicles may be unable to respond to accidents.

---

## CHILDREN AND VULNERABLE POPULATIONS

### Special Considerations

- Elderly and disabled individuals: ensure medications, medical equipment, mobility aids are prepared
  - Pregnant women: contact provider for extended outage planning
  - Infants: extra formula, diapers, wipes, medications (if applicable)
  - Children: comfort items (books, games, activities for extended indoors confinement)
  - People with mental health conditions: extra medication supply and coping strategies
  - Homeless individuals: identify warming centers and emergency shelter locations

## EMERGENCY INFORMATION AND RESOURCES

### Stay Informed

- Monitor NOAA Weather Radio for emergency alerts and updates
- Listen to local emergency management updates
- Follow official county social media for information
- Keep phone charged (use car charging if necessary)
- Register with county emergency alert system (if available)

- Use charcoal grills, camp stoves, or ovens for heating
  - Leave candles unattended or use as primary lighting
  - Travel during the ice storm unless life-threatening emergency
  - Ignore evacuation orders
  - Reopen refrigerator/freezer during outage to check contents
  - Use alternative heat sources without proper ventilation
  - Assume stores will be open or accessible after the storm

## RECOVERY AFTER THE STORM

### Immediate Aftermath

- Check on neighbors, especially elderly and vulnerable persons
- Report downed power lines to utility company (do NOT touch)
- Document property damage with photos for insurance
- Check food safety (discard items at unsafe temperatures)
- Use generator safely for at least one more day (assume power still unstable)
- Avoid using roads until cleared (debris, hazards, downed lines)

### Cleanup and Restoration

- Remove fallen branches safely (keep distance from power lines)
  - Restore heat and utilities gradually
  - Monitor for water damage and mold
  - Take photos for insurance claims
  - Contact insurance company for large losses
  - Report utility problems via company website or phone

## SUMMARY: PREPARATION CHECKLIST

### Complete Before Storm:

- ☐ Charge all phones, tablets, power banks, flashlights, lanterns
- ☐ Fill all vehicle fuel tanks
- ☐ Fill generator fuel containers (store safely)
- ☐ Stock 1+ gallon drinking water per person per day (4+ days)
- ☐ Stock 7+ days non-perishable food
- ☐ Stock 7+ days pet food and water
- ☐ Gather heating fuel or ensure fireplace/heater has fuel
- ☐ Collect and test flashlights, batteries, radio
- ☐ Freeze water containers (for cooling, drinking water)
- ☐ Ensure adequate blankets, winter clothing, hand warmers
- ☐ Fill bathtub with water (for flushing toilets)
- ☐ Stock personal hygiene supplies and toilet paper
- ☐ Fill prescriptions (7+ days supply)
- ☐ Gather first-aid kit, medications, medical supplies
- ☐ Ensure generators outside location is clear
- ☐ Test carbon monoxide and smoke detectors
- ☐ Disconnect outdoor hoses, wrap water spigots
- ☐ Stock pet items (food, water, shelter, medication)
- ☐ Prepare vehicle emergency kit
- ☐ Withdraw cash
- ☐ Gather important documents
- ☐ Prepare car with chains (if applicable)
